12. Vendors must be set up prior to 9:00 AM the day of the festival and may not break down prior to close of the event or 7:00 PM. 13. Vendors will comply with all safety and fire code standards. THE FIRE INSPECTOR WILL BE CHECKING ALL FOOD VENDOR BOOTHS.
